# People's Memorial Association starts its own funeral service cooperative

This past summer, People's Memorial Association (PMA), the nation's oldest and largest FCA-affiliate, started a member-owned cooperative funeral home to serve its members in Seattle.

Since it was founded in 1939, PMA contracted with Bleitz funeral home to provide low-cost funeral and cremation services to its members. In the mid 1990s, Bleitz was bought by Service Corporation International (SCI). Initially, the long-term relationship between Bleitz and PMA seemed unchanged, but SCI gradually transferred out long-term staff and brought in their own corporate people. Conflicts between Bleitz and PMA increased, and finally SCI cancelled the contract citing its determination that it wasn't making enough money from PMA members.

To continue offering low-cost services to its members, PMA began contracting with the Alderwoods Group. Last year Alderwoods was bought by SCI, which insisted on raising the contracted prices by 65%. When the PMA board refused to accept this unwarranted price increase, SCI cancelled its contract at the Alderwoods locations.

In response, the PMA board decided to pursue the long-time dream of having its own funeral home. Having a cooperative funeral home under PMA control assures both low costs for members and quality of service.

As explained by John Eric Rolfstad, PMA's Executive

Director, "People's Memorial Funeral Cooperative is a licensed funeral home establishment in the state of Washington. In compliance with Washington state law, we have a full-time licensed funeral director and three part-time funeral director interns. In addition there is an administrative assistant. We have been in regular communication with the staff at the state funeral board to make sure that we are in full compliance with state law. We have also already had our first on-site inspection by the state funeral board with no deficiencies. Our goal is to model a better way of providing funeral services."

Initially, the new coperative funeral service is available to members in the immediate Seattle area. Outside of Seattle (in Central Washington, Puget Sound, and the Kitsap/Olypic Peninsulas), PMA now contracts only with independent family-owned mortuaries. Eventually, PMA hopes to expand cooperative locations throughout its service area.

# Two former AMBIS Governing Council members die in 2007

Wally Ellinger, 88, longtime AMBIS supporter and former member of the Governing Council died in February. Vody Mills, 90, who served on the AMBIS Governing Council as Secretary for 20 years, died in August.

Wally served on the AMBIS Governing Council in the 1990s and shared his expertise in nonprofit leadership with the other Council Directors. Wally worked with the criminal justice reform group Citizens United for Rehabilitation of Errants for 16 years, and was active in the West Austin Democrats, the Texas AFL-CIO COPE Council, and the Austin Groups for the Elderly, where AMBIS has its office. Wally was a priest for 23 years and received a papal dispensation to marry Ruth Hunter Ellinger in 1976. Wally was proud to be called a "do-gooder," believing that if we don't do good, the other choice is not acceptable.

Vody had served on the "Death & Dying" Committee at the First Unitarian Universalist church in Austin, working with two current members of the AMBIS Governing Council, Ed Nichols and Daesene Willmann (who Vody recruited to be on the AMBIS Council). During the years Vody was a member of the AMBIS Governing Council, the Council frequently met at her house.

Vody was one of the early members of AMBIS. She and her late husband, Gordon Mills, joined in 1968.

Both Wally and Vody gave many years of service to AMBIS and contributed to the vitality that AMBIS now enjoys. The AMBIS family acknowledges their service and mourns their deaths along with their families and friends.  $\Omega$

# **Neptune Society opens Austin location**

The Neptune Society, a cremation service provider on the West coast since the early 1970s, has now opened three locations in Texas—in Ft. Worth, Houston, and Austin.

In a recent interview with the Editor of *Creative Choices*, Neptune Management Corporation President and CEO Jerry Norman explained that there are four Neptune groups, all of which are separate companies. The Neptune Society that he manages presently operates in ten states and has headquarters in Ft. Lauderdale, Florida. Its sole location in Austin is at 911 W. Anderson Lane.

Several AMBIS members have contacted the AMBIS office recently after receiving mailings from Neptune because of their concern that Neptune may have obtained their names and addresses from AMBIS. This is not the case. AMBIS has shared it's membership list twice with its national organization, Funeral Consumers Alliance, but will not share it with any other entity. Neptune's marketing plan in Austin consists primarily of mailings to lists of names and addresses of people aged 60 and over that were purchased from mailing list vendors.

Neptune strongly promotes prepaying for cremation services, a practice that AMBIS does not support unless a person is preparing to qualify for Medicaid and wants to pay for final arrangements, since irrevocable prepaid funeral contracts are not counted against Medicaid eligibility.

Neptune is moderately expensive. It uses two General Price Lists (GPLs)—one for preneed sales and one for atneed sales. Whether at-need or pre-need, Direct Cremation with an alternative container can be purchased for \$1592, though Neptune claims that its minimum price would be \$2066 at-need, but that includes some items that are unneeded by most families, like common scattering of the cremated remains at sea. The average direct cremation cost in the 2007 AMBIS survey of funeral costs is \$1642. Fifteen Austin-area cremation providers surveyed provide direct cremation for less than Neptune's \$1592 charge.

However, Neptune offers a "Direct Cremation Package" for \$1389, whether purchased at-need or pre-need. When purchased at-need, the package does not include a "Neptune Information Guide and Portfolio" (valued at \$249). The package does include an urn valued at \$349. The wholesale cost of both the information package and the urn is probably less than \$100. Thirteen Austin-area providers offer direct cremation for less than \$1389.

When purchasing pre-need, Neptune offers "Transportation Protection" for \$399. If a purchaser dies more than 75 miles from where the pre-need contract was purchased, Neptune guarantees service at no additional cost.

A 20 ga. steel casket at Neptune costs \$1,895, higher than the cost of a 20 ga. casket charged by all of the serv-

In case you have missed it, there is a growing interest in home funerals and "natural burials." The article linked to FCA's website.

The public television show Point of View repeated "A Family Undertaking," a documentary about the home funeral movement. AMBIS received referrals through the FCA office of Austin-area people who contacted them as a result of the article and the program.

The return by some families to home funerals reminds me of the 1960's, when families reclaimed the birthing process, as natural a process as death. Crossings Care Circle, Central Texas' home funeral group, is getting increased calls. Some families wish to participate in part of the preparation of the body and some have done all of the preparation because of their desire to experience the positive benefits of hands-on caring of a loved one who has died.

Crossings Care Circle has two available coffins: one a plain wooden box and the other an "alternative container," suitable for use when the choice is cremation. Both are available at cost.
