2018 Cemetery Survey

Every other year, Funeral Consumers Alliance of Central Texas publishes a cemetery survey listing prices at a **representative sampling** of hundreds of city-owned and privately-owned cemeteries in Bastrop, Caldwell, Hays, Travis, and Williamson counties. The survey includes information about niches and burial plots for cremation urns.

For veterans and their spouses, the survey provides information about the Central Texas State Veterans Cemetery in Killeen and the two national Veterans Cemeteries in San Antonio.

Data for the current survey were collected in July, 2018. Information was gathered in person, by email, and by phone. In some instances – primarily city cemeteries, Assumption Cemetery, and Eloise Woods in Cedar Creek – prices were available online.

Death Abroad



When a U.S. citizen dies abroad, the Bureau of Consular Affairs assists the family and friends. The Bureau of Consular Affairs attempts to locate and inform the next-of-kin of the U.S. citizen's death. The Bureau of

Consular Affairs provides information on how to make arrangements for local burial or return of the remains to the United States. The disposition of remains is subject to U.S. and local (foreign) law, U.S. and foreign customs requirements, and the foreign country facilities, which are often vastly different from those in the United States.

The Department of State has no funds to assist in the return of remains or ashes of U.S. citizens who die abroad. The Bureau of Consular Affairs assists the next-of-kin to convey instructions to the appropriate offices within the foreign country, and provides information to the family on how to transmit the necessary private funds to cover the costs overseas. Upon issuance of a local (foreign) death certificate, the nearest embassy or consulate may prepare a **Consular Report of the Death of an American Abroad**. Copies of that report are provided to the next-of-kin or legal representative and may be used in U.S. courts to settle estate matters.

Burial at Sea Program

Burial at Sea is a means of final disposition of remains performed on United States Navy vessels. The committal ceremony is performed while the ship is deployed from one of these ports of embarkation:



- Norfolk, VA
- Jacksonville, FL
- San Diego, CA
- Bremerton, WA
- Honolulu, HI

Family members are not allowed to be present. Once the committal service has been completed, the commanding officer of the ship assigned to perform the ceremony will notify the family of the date, time, and longitude and latitude.

Eligibility: Individuals eligible for this program are: (1) active duty members of the uniformed services; (2) retirees and veterans who were honorably discharged; (3) U.S. civilian marine personnel of the Military Sealift Command; and (4) dependent family members of active duty personnel, retirees, and veterans of the uniformed services.

How to get started: After the death of the individual for whom the request for Burial at Sea is being made, the **Person Authorized to Direct Disposition** should contact the Navy and Marine Corps Mortuary Affairs office at 1-866-787-0081 to request a packet and additional information. Phones are answered weekdays from 7:30 a.m. to 4 p.m. CST.

Texas Department of Banking Says Austin-Peel and Son Illegally Sold Trust-Funded Prepaid Funeral Contracts

Austin-Statesman: State seizes funeral home documents

The Texas Department of Banking has taken custody of the records and funds relating to illegal prepaid funeral benefit contracts sold by Billy F. Peel and Austin Peel and Son Funeral Home Inc.

Customers who purchased trust-funded prepaid funeral contracts from Austin-Peel that have not been serviced should contact the department by calling 877-276-5554, selecting 3 for inquiries/complaints and then 5 for funeral contracts/cemeteries; by calling 512-475-1285; or emailing pfcpc@dob.texas.gov.

Those contacting the department about contracts should have supporting documents ready. The department said Austin-Peel violated Chapter 154 of the Texas Finance Code by selling prepaid funeral benefit contracts and collecting related funds without a permit issued by the department. The department served Austin-Peel with an emergency cease and desist order Thursday [August 2], ordering it to stop selling trust-funded prepaid funeral benefit contracts and collecting associated funds. Department officials said seized records indicate that about 250 illegal contracts were issued.

Vatican's Stance on Disposition of Cremated Remains

On October 25, 2016, the Vatican responded to what it called an “unstoppable increase” in cremation and issued [guidelines](#) barring the scattering of ashes “in the air, on land, at sea or in some other way.” Further, the Vatican decreed that the ashes of loved ones have no place in the home and certainly not in jewelry [or other “memorial” products such as paperweights, tattoo ink, and shotgun shells].

The Vatican urged that cremated remains be preserved in cemeteries or other approved sacred places. Families wishing to keep the cremated remains at home must receive permission from the Bishop of their Diocese. Details at <https://tinyurl.com/jk4bhjy>.

Airline Regulations for Traveling with Cremated Remains



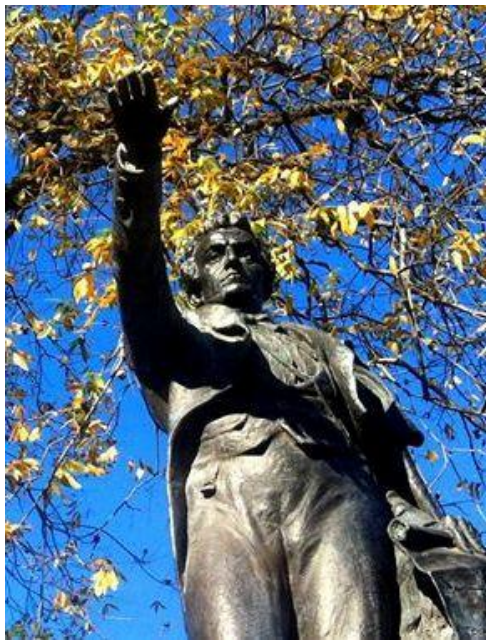
Before you make your reservation, check to see the airline's rules and regulations for traveling with an urn containing cremated remains.

The Basics:

- The decedent's family pays for everything but the plot. Specifically, they pay for the opening/closing, the grave liner, and the marker. There are no exceptions, no matter what the status or rank of the deceased.
- Grave liners are required for casket burial. Grave liners are not required for urns but "the urn must be of quality craftsmanship. The spreading of ashes shall be approved by the superintendent."
- The cemetery permits cenotaphs (monuments erected in honor of individuals eligible for burial in the Cemetery whose remains are buried elsewhere).
- Grave liners, markers, and cenotaphs become the property of the State of Texas.

Known as the nation's most hallowed ground, Arlington National Cemetery is the final resting place of over 400,000 people including military service members, slaves, presidents, unknown soldiers and more. The cemetery holds about 7,000 funerals annually, which averages out to 30 funeral services every day.

Eligibility

Arlington National Cemetery's eligibility requirements for burial and inurnment are different from other national cemeteries that are maintained by the [Department of Veterans Affairs](#). Eligibility for in-ground burial at Arlington National Cemetery is the most stringent of all U.S. national cemeteries. However, most veterans, who have at least one day of active service for other than training and were issued an Honorable Discharge, are eligible for above-ground inurnment [of cremated remains]. Cremated Remains

Arlington National Cemetery requires certification of 100% of cremated remains and a cremated remains certificate. We support the industry best practices of including the cremation identification number, which is included with the remains and annotated on the cremation certificate. **Arlington does not accept cremated remains by mail.**

FACT: Burial on private property in an incorporated city, town, or village is subject to that entity's zoning regulations or other related ordinances. Burial outside a municipality is generally unregulated. Burial on private property creates an encumbrance on the land if it is ever sold. One Plot at Austin Memorial Park Cemetery

2800 Hancock Drive, Austin, TX

In 2016, the Seattle-based granddaughter of Stephen D. Heffington, Sr. (Travis County Tax Collector-Assessor, 1925-1962) donated three plots to FCACTX for fundraising purposes. Two plots have been sold. **Plot 6**, located in **Section 1**, Lot 464, is still available.



To see where the plot is located:

1. From main entrance road, take the left fork. Drive 2/10th of a mile.
2. Turn left. In about 1/10th of a mile, look for the COOPWOOD marker on the right and the WOOLWINE marker on the left (just to the right of a park bench facing the road).
3. **Park.** Walk towards the trees. Pass the PUCKETT marker.

The available plot is near the grave markers for the **HEFFINGTON** family.

Austin Memorial is currently selling adult plots for \$3,191.25, which includes a 15% perpetual care fee. FCACTX is offering the donated plot for \$2,000. The \$50 deed recording fee is the responsibility of the purchaser.

Five Plots at Cook-Walden Capital Parks

14501 North IH-35, Austin, TX

Several years ago, Maurine Kocurek donated to our organization five plots at **Cook-Walden Capital Parks**. Four of the donated plots are Graves 1, 2, 3, and 4 in Section H, Block 90-C. The fifth plot is Grave 1 in Section H, Block 90-D.

To see where the plots are located:

1. From IH-35 North, take exit 247 for Wells Branch Parkway/Pflugerville. Turn into the cemetery's main entrance.
2. At the first intersection in the cemetery, turn left.
3. Driving down the road, look to the left for the **TOUNGATE memorial bench**. (As you face the bench, a long walkway will be behind you, just on the other side of the road.)
4. **Park.** Walk a short distance towards the large tree. The plots are located to the right of the tree and to the left of markers for the GRANT family.

Cook-Walden is currently selling plots in Section H for \$5,495. FCACTX is offering the donated plots for \$2,500 each, plus Cook-Walden's \$395 deed transfer fee.

Headstones, Markers and Medallions for Honorably Discharged Veterans interred in non-veteran cemeteries

Public Law 110-157, signed on Dec. 26, 2007, allows the Department of Veterans Affairs (VA) to furnish a Government headstone or marker for the graves of eligible Veterans who died on or after Nov. 1, 1990, regardless of whether the grave is already marked with a privately purchased headstone or marker.

This same law also gives VA authority to "furnish, upon request, a [medallion](#) or other device of a design determined by the Secretary to signify the deceased's status as a Veteran, to be attached to a headstone or marker furnished at private expense."



There is no charge for the headstone or marker itself; however arrangements for placing in a private cemetery are the applicant's responsibility, and all setting fees are at private expense.

Important: Eligible Veterans are entitled to either a Government-furnished headstone or marker, or the new medallion, but not both.

There is no change in eligibility for Veterans in unmarked graves: Regardless of the date of death, VA will furnish, at no charge to the applicant, a Government headstone or marker for the unmarked grave of any eligible Veteran in any cemetery around the world.

Texans Have the Legal Right to Authorize Cremation Prior to Death

Texas allows a person to sign his or her own cremation authorization **prior to death**.

The normally required post-death Cremation Authorization Form is NOT required if the decedent left written instructions as provided by the law regarding pre-death authorizations. (See the Texas Health and Safety Code 716.054 at www.statutes.legis.state.tx.us/Docs/HS/htm/H.S.716.htm.)

Completion of the authorization form, the **Body Disposition Authorization**, does not require the involvement of a funeral director.

You can find this disposition directive on the FCACTX website at www.fcactx.org. Click

on the **Resources** tab. Then, on the dropdown menu, click on **Advance Directives forms**.

On the same Advance Directives web page, you will find another disposition directive, the **Appointment for Disposition of Remains**. This directive authorizes the named agent to approve a cremation or any other disposition option.

Both forms require signature in the presence of a notary.

Update on Class Action Lawsuit against SCI Direct dba Neptune Society

You may remember from a 2016 **Creative Choices** newsletter (issue 3), a class action lawsuit was filed against SCI Direct, claiming they – doing business as The Neptune Society – violated the Telephone Consumer Protection Act by making calls through the use of an artificial or prerecorded voice without the recipients' permission to make these calls.

Good news for consumers: The lawsuit has been settled and claimants have been paid. One FCACTX member reported recently receiving a settlement check in the amount of \$129.85.

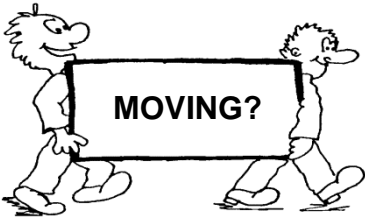
