## Wonderful Windfall Fundraising Opportunity for AMBIS


Dear AMBIS Family and Friends –

We listened on your behalf as several of them talked freely about the common practice of asking a family member to sign the embalming authorization at the very time a loved one's body is being taken away! Legally, they **can** do that **if** they provide a General Price List.

**But how many people know that embalming is an option rather than a requirement?**

Until that utopian day when consumer education and advocacy are not needed, please help us keep spreading the word by volunteering and donating!



Thereafter, he served not only as Council President but also as Board President of the Funeral Consumers Alliance, to which he still provides legal counsel.

For all the newsletters, for all the annual surveys, for all the workshops you conducted, for all the answers, guidance and wisdom you have provided, we thank you, Lamar.
